

Instructions for Searching 28E Filings

Participant Name

Use this field to search by the name of the organization that is partner to a 28E agreement. Participant Name is filed using the full legal name of each organization participating in the agreement. Examples include: City of Des Moines, Ames Community School District, County of Polk, Iowa Department of Revenue.

Service Type

Public Service Type Codes

LAW ENFORCEMENT

- 110 Police Protection
 - Patrol, Pursuit, tickets, crowd control, parking
- 120 Jail & Corrections
 - including prisoner transfer, juveniles, community corrections
- 130 Emergency Management
 - including 911, ambulance and emergency management
- 140 Criminal Investigations
 - including detectives, crime labs, drug enforcement

FIRE SERVICES

- 210 Fire Response
- 220 Hazmat Response

HIGHWAYS & PUBLIC WORKS

- 310 Water System
 - including water, wastewater, storm water systems, utilities, wells
- 320 Electric & Energy Systems
 - including utilities, resale of power, gas utilities
- 330 Engineering
- 340 Facilities
- 350 Street & Road Systems
 - including bridges, streets, signaling, right-of-way, RR crossings
- 360 Sanitation
- 370 Other
 - including golf courses, flood projects

TRANSPORTATION

- 410 Public Transit

 - including driver licensing, car registration
- 440 Other (including railroads)

COMMUNITY & NEIGHBORHOOD SERVICES

- 510 Parks and Recreation
 - including hunting and fishing licenses, conservation programs
- 520 Library Services

 - including public housing, housing assistance, building inspection, code enforcement
- 550 Economic Development
 - including tourism, business promotion, unemployment/job services
- 560 Planning
 - including building permits, zoning, inspections, other planning
- 570 Other
 - including elderly services, child support collections

- 610 Information Services
- 620 Purchasing Services

COURT AND LEGAL SERVICES

ELECTED OFFICIALS, BOARDS, & COMMISSIONS

- including boundaries agreements, changing boundaries, voter registration

EDUCATION

- any education service, including school resource officers, transportation, but excludes workforce development/job training (filed under economic development)

Agreement File Date

Use this field to search agreements by date(s). If you know the date on which the agreement was filed with the Secretary of State, then included that date in both fields (from/to).

Organization Type

Use this field if you want to search for a particular type of organization. You may choose: State of Iowa, County, City, Township, School District, Fire Department, and Other (to search for agreements that do not include one of the above types of organizations).

County

Use this field to search for all agreements filed in a specific county, including for that county itself.

Region

Use this field to search for all agreements filed in a specific region of the state. Click on [Map of regions](#) to access a map that identifies which counties are assigned to a region. The regional map closely resembles the map of regional councils of governments (COGs).

Filing Number

Use this field if you know the filing number of the 28E agreement. The filing number usually begins with the letter L or M followed by numbers, e.g., M002759.
